• **Purchase of Bidding Document**

The Bidder have to registration on our purchase portal (<http://purchase.dudhdharadairy.in/>)

After payment of nonrefundable price of the bid document (**Rs.1,180/-**) (Inclusive of GST) through RTGG/NEFT/Fund Transfer to “ **THE BHARUCH DISTRICT CO OPERATIVE MILK PRODUCERS UNIO LTD**”, payable at **BHARUCH**, (Bank details as mentioned below) on all working days (Monday to Saturday, except public holiday). (working hours - 09:30 hrs. ot 17:00 hrs.)

After successful receipt of the Bid document price, the bidder have to download the tender document from <http://purchase.dudhdharadairy.in/>

• **Submission of Bid**

The bidders, who purchase the bidding document, are eligible for submission of bids in their name only.

• **Bid Security**

All bids must be accompanied by bid security (Earnest Money Deposit – EMD) in the form specified in the bidding document. The bids not accompanied with EMD shall be summarily REJECTED . The bid security shall be denominated in Indian Rupees of value as specified and shall be in the form of Demand Draft from Nationalized or Scheduled Banks or Through RTGS/Fund Transfer (Bank detail is as below for your reference).

• **The Bid security may be forfeited if**

A bidder or supplier withdraw its bid during the period of bid validity specified by the bidder/ supplier on the bid form or

In case of successful bidder/ supplier, if the bidder/ supplier fails to sign the contract.

- 4) Interested bidders have to submit their technical specification/detail first, only after technical evaluation/approval, bidders will be invited for submission of commercial bid.
- 5) Submitted commercial bid were open on mentioned due date and time in presence of bidder's representative.

- **Submission & Opening of Bids**

This is a two stage bid. All the bidders shall submit the bids through online platform

Phase- II- Only technical qualified/Successful Bidders invited to submit their commercial bid through online portal.

The technical bid shall contain all the details except for the price.

Deviation sheet needs to be submitted separately and with justification of offered item/feature.
